# ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION OF BREEZY VILLAGE ASSOCIATION, INC., A NON-PROFIT CORPORATION

Pursuant to the provisions of Section 617.1006, Florida Statutes, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- A. The name of the Corporation is Breezy Village Association, Inc., a Non-Profit Corporation.
- B. The following Articles of the Articles of Incorporation of Breezy Village Association, Inc. have been amended as follows:
  - 1. Article VIII BY-LAWS was amended as follows:

## ARTICLE VIII BY-LAWS

The power to alter, amend, or repeal the By-Laws of this Corporation shall be vested in the members as provided in the By-Laws.

No person, firm or corporation shall ever receive any dividends or profits from the undertaking of this corporation and upon dissolution of this organization all of its assets remaining, after payment of all cost and expenses of such dissolution, shall be distributed as specified in the Plan of distribution of assets as adopted, and in compliance with applicable law of the State of Florida.

C. The foregoing amendments to the Articles of Incorporation were duly adopted by the Directors of the Corporation at a Special Meeting held on the 3rd day of February, 1997.

D. The foregoing amendments to the Articles of Incorporation were duly adopted by more than a two-thirds vote of those members of the Corporation present at a Special Meeting held on the 3rd day of February, 1997 and the number of votes cast for the amendments was sufficient for approval.
